Membership

Total membership of EUROCALL fell from 438 to 380. The issue of trying to boost membership is being seriously addressed by the Executive Committee. Finance

Income in membership fees amounted to £19,708. The surplus from the Dundee conference had not been received by the year-end, and the predicted profit from *ReCALL* subscriptions was not achieved, thus the budgeted deficit of £2,600 actually became a deficit of £8,144. It was hoped that a small overall surplus would be generated in the year 2001-2002.

Publication

Two issues of *ReCALL* were distributed via Cambridge University Press. These were made available to subscribers electronically by password access.

Despite considerable investment by CUP in the marketing of *ReCALL*, library subscriptions were not as high as predicted. It was hoped that this situation would improve, once *ReCALL* becomes more visible, especially in North America. The Editorial Board for the year 2000-2001 is listed below:

Enquiries and visitors

Over the year, the Hull team dealt with 50 enquiries from EUROCALL members and received 4 visitors who spent time, usually relating to their research, examining software and publications in the dedicated CALL libraries held at Hull.

Discussion list

At the end of the period in question, there were 271 registered users of the [discussion list](#). The list is open to members and non-members alike and continues to be regularly used.

Website

The EUROCALL website at www.eurocall.org continues to be maintained and enhanced by Fred Riley who has also made a number of improvements to the accessibility of resources via the Subject Centre site.

Regional representatives

Stephan Pohlmann has continued to co-ordinate the national / regional representatives, who act as contacts in their own particular regions, to stimulate relevant activity locally and to promote membership of EUROCALL. Local websites have been established in Denmark, France, Germany, Greece, Ireland and Spain. The representatives meet annually at the conference to share ideas, and the Co-ordinator of the representatives is co-opted onto the EUROCALL Executive Committee as an observer.

Conference

Another successful annual conference was held at the University of Abertay Dundee, organised by Philippe Delcloque. A highlight of the conference was the [History of CALL Exhibition](#), organised by Philippe and jointly funded by EUROCALL and CALICO. A selection of papers from the conference were published in *ReCALL* volume 13.

Research Award

There were four submissions for the annual EUROCALL Research Award, 2001. All were of high quality, and it was decided to allow all candidates an opportunity to revise their papers in the light of reviewers' comments, before making the award.

The János Kohn Scholarship

Péter Gál of the University of Veszprem, Hungary, attended the Dundee conference as holder of the 1999-2000 Scholarship. His report on the conference was published in *ReCALL* 12 (2).

There were four applications for the 2000-2001 Scholarship, which was awarded to Ida Dringo-Horvath of the Eötvös Loránd University, Budapest for attendance at the Nijmegen conference.

Special Interest Groups
