EUROCALL Annual Report 2002/2003

Headquarters and secretariat

EUROCALL went ahead with arrangements to transfer its headquarters from the Language Institute at the University of Hull to The Department of Language & Cultural Studies at the University of Limerick, Ireland in September 2003. June Thompson and Graham Chesters were both due to retire from their respective posts as Secretary and Treasurer at the University of Hull, and the University of Limerick was identified as an appropriate venue for the new headquarters.

Margaret Gammell was appointed as Secretary and Angela Chambers as Treasurer, from 1st September 2003.

Finance

Income in membership fees amounted to €28,910/£17,346. A surplus of €8,000/£5,000 was received from the Jyväskylä Conference. However, there was an overall deficit of €6,517/£3,910 for the year. This was due mainly to conference surplus targets not being met, and a drop in membership. A small overall surplus would be budgeted for in the year 2003-2004.

Publication

Two issues of ReCALL were distributed via Cambridge University Press. These were also made available to subscribers electronically by password access.

Accounts from CUP showed that for the first time a small net surplus had been generated in the calendar year 2002, with an encouraging forecast of a further surplus in 2003. The Editorial Board for the year 2003-2004 is listed below:

Discussion list

At the end of the period in question, there were 288 registered users of the discussion list, the same number as on the previous year. The list is open to members and non-members alike and continues to be regularly used.

Website

The EUROCALL website domain of www.eurocall.org having expired, a new domain was found at www.eurocall-languages.org. The website continued to be maintained and enhanced by Fred Riley from Hull with intention to move to a new server at the University of Limerick during 2004.

Regional representatives

Stephan Pohlmann has continued to co-ordinate the national/regional representatives, who act as contacts in their own particular regions, setting up local websites to stimulate relevant activity locally and to promote membership of EUROCALL. The representatives meet annually at the conference to share ideas, and the Co-ordinator of the representatives is co-opted onto the EUROCALL Executive Committee as an observer.

Conference

Another successful annual conference was held in September 2002 at the University of Jyväskylä, Finland, organised by Peppi Taalas. A selection of papers from the conference were published in ReCALL volume 15.

The Annual EUROCALL Research Award

The winner of the Research Award for 2002 was Gabriela Adela Gánem Gutiérrez of the University of Southampton. Runner-up was a joint paper by Freda Mishan and Bob Strunz of the University of Limerick. Both papers were published in ReCALL Vol. 15.

The János Kohn Scholarship

Mr Gyula Tankó of Eötvös University, Budapest, Hungary, attended the Jyväskylä conference as holder of the 2002 Scholarship. His report on the conference was published in ReCALL 14 (2).

Ms Zsuzsanna Angeli was awarded the Scholarship for 2003, for attendance at the Limerick conference.

A successful pre-conference workshop was held at the Jyväskylä conference by the Language Processing SIG. This SIG and the Instil SIG is operated jointly with CALICO.
