Membership

Total membership of EUROCALL increased from 325 to 419. This increase came about as a result of a decision by the Executive Committee to award membership for the current year to members joining at the annual conference. Previously, membership of new joining members only came into effect the following year. It is hoped that this initiative will show instant benefits of membership to new members and thus help keep them on board. The table below gives a breakdown of the countries represented. EUROCALL continues to operate a reciprocal arrangement with affiliated associations such as CALICO, so that members of these associations are entitled to certain EUROCALL benefits and vice-versa.

Finance

Income in membership fees amounted to $\le 28,773$. A surplus of $\le 15,597$ was received from the Limerick Conference. This, along with an additional sum of $\le 1,422$ received from an earlier conference at Nijmegen, resulted in an overall surplus of $\le 7,451$. However, in spite of this positive outcome, a small deficit would be budgeted for the year 2004-2005. This would allow for an overall increase in the cost of the *ReCALL* Journal, which was being distributed to new joining members in 2004.

Publication

Two issues of *ReCALL* were distributed via Cambridge University Press. These were also made available to subscribers electronically by password access.

Accounts from CUP showed that a small net surplus had been generated in the calendar year 2003, with an encouraging forecast of a further surplus in 2004. The Editorial Board for the year 2004-2005 is listed below:

Regional representatives

Stephan Pohlmann has continued to co-ordinate the national/regional representatives, who act as contacts in their own particular regions, setting up local websites to stimulate relevant activity locally and to promote membership of EUROCALL. The representatives meet annually at the conference to share ideas, and the Co-ordinator of the representatives is co-opted onto the EUROCALL Executive Committee as an observer.

Conference

Another successful annual conference was held in September 2003 at the University of Limerick, Ireland, organised by Angela Chambers. A selection of papers from the conference was published in *ReCALL* volume 16.
